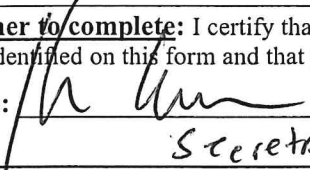

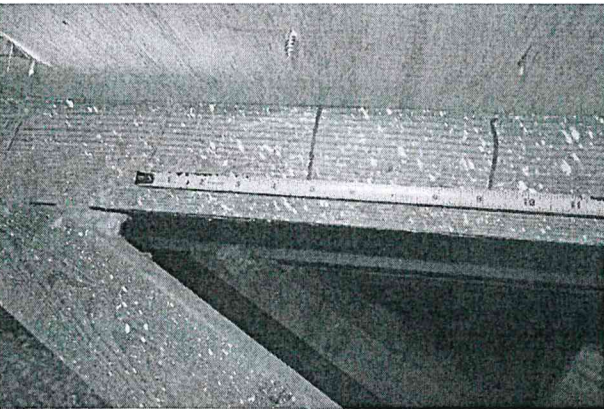

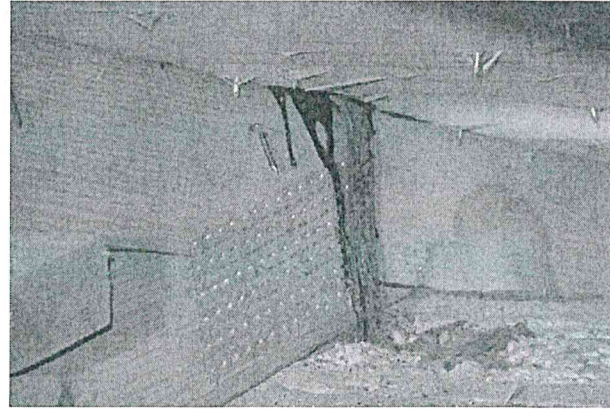
Nail location verified

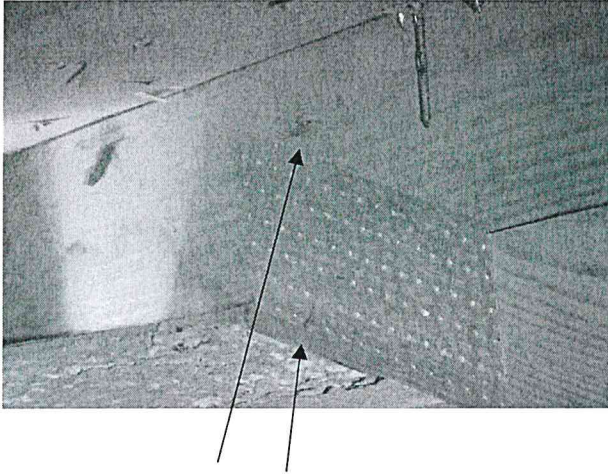


Single strap with 2 nails into the truss
